orphans. We provided the funds to build a cement building to house the bakery. Just One: Africa provided the bread oven, mixer, proofer, bread tins, and initial funds to cover staffing expenses. The baker is producing approximately 200 loaves of bread a day. The bakery has provided jobs and food for the surrounding community, sustainable income for the orphanage, as well as consistent food for the orphans.

2. Education - School Building

Salem Orphanage held classes under the trees at the farm and was in need of a building to hold classes for the orphans. Just One: Africa provided the funds to build a brick school building that was 30 feet by 60 feet. This building houses 6 grade levels totaling 60 students. This building ensures that the kids are able to be educated all year round. Just One: Africa also provided curriculum and other needed school resources that enabled the teachers to teach at a higher level to all the students.

3. Water Filters

In Kenya many people have access to water, but it is not clean, causing tremendous problems with water-borne disease. Just One: Africa provides Sawyer filters capable of filtering 1 million gallons with no replaceable parts. Each filter provides clean water for up to 20 people for life. We have distributed 285 water filters in Kisumu, Bondo, Amboseli, Kendu Bay, and Mageta Island, which provides clean water for up to 5,700 people. Our follow up has shown that in just a matter of a few weeks, health has dramatically improved, and deaths from water-borne diseases have declined incredibly. This clean water has enabled children to return to school and parents to continue in
