analyze with an app that was specifically created to tract pre- and post-distribution data so that JOA can carefully monitor our success and make any adjustments in the areas in which we serve.

- We are also using a paper system so that we have a hard copy, but we are testing an app that allows us to capture the GPS location of the filters. Adding all the info into the app allows it to be uploaded and shared in a cloud based system that is accessible anywhere in the world.

- Notes: The JOA Clean Water Program saw an incredible increase in 2015, distributing 200 water filters OVER our original 1000 goal! Our goals were exceeded because of our donors' consistent support and was also made possible by the purchases of our recycled paper jewelry that helps to fund our Clean Water Program.

- Bracelet program - our Recycled Paper Bracelet Program continues to thrive and be a very significant support to our Clean Water Program. It provides sustainable income to the Masai mamas from whom we purchase the beads and also provides volunteer opportunities for young people, corporate team building, and others as they help us to string the beads into bracelets. There are now many established Just One Africa clubs in our local schools here in the U.S. with even more being started in the 2016-2017 school year. Scout troops and other local groups also schedule with us for stringing events from week to week. We are able to share the Just One Africa vision as well as educate young people about the needs and challenges in the areas in which we serve.
